# Other Student Nurses (not including Peach course)

Must be studying for relevant qualifications (letter of confirmation from College must be supplied).

## **YT Trainee**

Must be under 25 and on an approved Training Plan under the Employment and Training Act 1973. (Letter of confirmation from employer must be supplied)

## Apprentices

Must be learning a trade, business or profession, **and** the training leads to qualifications which if attained would normally result in a substantial increase in salary. (Letter of confirmation from employer must be supplied).

Gross weekly salary or allowance whilst training must not exceed £195.

Higher rate attendance allowance, or the highest rate care component of a disability living allowance, or the highest rate of disablement pension, or an increased rate of constant attendance allowance.

The Carer must live with the person, and provide care for 35 hours per week. The person they are caring for must not be their Spouse or Partner, or their child if he or she is under 18 years old.
