7. Area Proposed

The proposed 'Neighbourhood Area' consists of the entire parish area administered by Crosby Ravenworth Parish Council. This includes the villages of Crosby Ravensworth, Moulds Meaburn, Reagill and the additional villages, hamlets and surrounding countryside included within the boundaries of the parish.
