

Order for the Extension of a Public Spaces Protection Order under The Anti-Social Behaviour, Crime and Policing Act 2014
WESTMORLAND AND FURNESS COUNCIL
The Dogs Exclusion (Eden) Order 2023

Westmorland and Furness Council in exercise of its powers under section 60 of the Anti-social Behaviour, Crime and Policing Act 2014 (“the Act”), hereby extend the Dogs Exclusion (District of Eden) Order 2008 (“the Order”) by making the following Order:-

THIS ORDER is made by Westmorland and Furness Council (“the Council”) because the Council is satisfied on reasonable grounds that the conditions at section 59 (2) and (3) are met as follows:

- activities carried on or likely to be carried on in a public place have had or are likely to have a detrimental effect on the quality of life of those in the locality,
- the effect or likely effect of the activities is or is likely to be, of a persistent or continuing nature,
- the effect or likely effect of the activities is or is likely to be, such as to make the activities unreasonable, and
- justifies the restrictions imposed by the notice

AND that an extension of the Orders is necessary under section 60(2) to prevent-

- (a) occurrence or recurrence after that time of the activities identified in the order, or
- (b) an increase in the frequency or seriousness of those activities after that time.

Restricted Area

1. **The Public Open Space** to which this order applies is that land specified in the Schedule.

Commencement

2. **This Order** comes into force on 19th October 2023 .

Offence

3. (1) A person in charge of a dog shall be guilty of an offence if, at any time, he takes the dog onto, or permits the dog to enter or to remain on, any land to which this Order applies unless
 - (a) he has a reasonable excuse for doing so; or
 - (b) the owner, occupier or other person or authority having control of the land has consented (generally or specifically) to his doing so.
- (2) Nothing in this article applies to a person who

- (a) is registered as a blind person in a register compiled under section 29 of the National Assistance Act 1948; or
 - (b) is deaf, in respect of a dog trained by Hearing Dogs for Deaf People (registered charity number 293358) and upon which he relies for assistance; or
 - (c) has a disability which affects his mobility, manual dexterity, physical co-ordination or ability to lift, carry or otherwise move everyday objects, in respect of a dog trained by a prescribed charity and upon which he relies for assistance.
- (3)** For the purposes of this article
- (a) a person who habitually has a dog in his possession shall be taken to be in charge of the dog at any time unless at that time some other person is in charge of the dog; and
 - (b) each of the following is a "prescribed charity"
 - (i) Dogs for the Disabled (registered charity number 700454);
 - (ii) Support Dogs (registered charity number 1088281);
 - (iii) Canine Partners for Independence (registered charity number 803680).

Penalty

4. A person who is guilty of an offence under article 3 shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.

Duration of Order

5. This order shall remain in force for a period of three years unless extended under section 60 of the Act 2014.

Appeal

6. An interested person may apply to the High Court to question the validity of this order on the ground that the local authority did not have power to make the order or that it has not complied with a requirement of the Act. An Appeal must be made within 6 weeks of the date on which the order is made.

SCHEDULE

This Order applies to the following land in the area of Eden within the District of Westmorland and Furness:

1. Frenchfield sports pitches, Carleton, Penrith
2. Castletown Recreation Field, Gilwilly Road, Penrith
3. The following fenced or otherwise enclosed children's play areas in the District of Eden:

Appleby

Barrowmoor - open space behind Barrowmoor Road/Margaret's Way

King George V Field - park adjacent to Broad Close car park

Bampton - playing field opposite school

Bolton - behind village hall

Clifton - adjacent to school

Crosby Ravensworth - behind bus shelter

Great Asby - at far end of village

Kirkby Thore - Behind Village Hall

Penrith

Carleton Heights - open space adjacent to Birch Close

Castletown - playing field, Mill Street

Milton Street - open space adjacent to Milton Street

Pategill - open space off Prince Charles Close

Scaws - open space adjacent to Pennine Way

Laites - adjacent to first house on left (from Penrith)

Newton Reigny - adjacent to bridge

Shap - adjacent to swimming pool

Soulby - adjacent to bridge

Tebay - alongside South Terrace

Tebay - by Tennis Courts Tebay

Threlkeld - playing field adjacent to school
